The price rate of B3CAFE WIFI services is selling at Ringgit Malaysia one (RM1) for ninety (90) minutes of usage, Ringgit Malaysia six (RM6) for one (1) day usage, Ringgit Malaysia fifteen (RM15) for one (1) week usage, Ringgit Malaysia thirty five (RM35) for one (1) month usage, and Ringgit Malaysia three hundred (RM300) for one (1) year usage.

3.2 The minimum amount of B3CAFE WIFI Credits top-up (first time) will be Ringgit Malaysia five hundred (RM500). For B3CAFE WIFI Credits top-up second time and onwards, the minimum amount of top-up will be Ringgit Malaysia one hundred (RM100).

5.2 Customer must ensure the venue is ready and available for equipment installation upon the arranged date, and ensure there will be a person in charge to standby and assist if required during the equipment installation process.
